## Arawak Walton Given Top Marks by Regulator

We are very pleased to announce that we have received the highest possible regulatory judgement from the Homes and Communities Agency (HCA)

### G1 / V1

Following continued growth, Arawak Walton moved into mainstream regulation in 2016 due to owning over 1,000 homes.

After completing an in depth assessment (IDA), earlier this year, the Homes and Communities Agency awarded Arawak Walton Housing Association a rating of G1/V1. This rating is the highest grading achievable and confirms that Arawak Walton benefits from robust governance and are financially viable respectively.

Ms Cym D'Souza, Arawak Walton's Chief Executive, said "At a time when the social housing sector faces many challenges, this is a fantastic result. Sound governance and financial stability are essential in allowing us to do what we do in the community."

Evelyn Asante-Mensah, Arawak Walton's Chair, said "We are delighted with the rating that the HCA has given us. It is recognition of the importance we put on ensuring that we have high standards of governance and that the Board, executive and all our staff at Arawak Walton have the highest level of governance within the organisation and skills to provide our housing and services to our communities. The HCA has set the bar high and it is up to us to make sure that we continue to maintain this level of quality. The assessment of our financial health and Governance will help us to continue to deliver high quality homes and services."

Arawak Walton currently has 1052

properties in Manchester, Trafford and Stockport.





### **Annual General Meeting**

The association's Annual General Meeting took place in September 2017.

Shareholders attending the AGM heard that the association had achieved an increase in turnover to over £5.39million (£5.36 million last year) despite the 1% rent cuts. It was also noted that £2.2 million was spent on acquiring and refurbishing new properties and £290k on replacing components in existing properties. Our operating margin has also increased to 37% (35% in 2016).

Shareholders were delighted to hear that the association had another year of strong financial performance with funding in place for future investment. As a not for profit organisation, all the association's surpluses are reinvested in new homes and refurbishment of existing homes.

Thanks were given to the Staff, the Board, founder members, our partners, members of the Tenants Quality Panel and our lenders for their continued commitment and support.

The Chair thanked all the Board members stepping down especially Ms Lorri Holding who had served a maximum 9 years on the Board. The Chair thanked Ms Holding for her dedication and wished her the best for the future.



### **October Board Meeting**

At the previous September special policy meeting members formally appointed Evelyn Asante-Mensah as Chairperson, David Brown as Deputy Chair and Hilda Kaponda as Honorary Secretary.
