

ANNUAL GENERAL MEETING

The Association's Annual General Meeting took place in September 2020.

Due to the current COVID-19 restrictions, it was the first time we have held our AGM via video conferencing. We found that we were still able to hold a productive meeting, despite all being located remotely.

Shareholders attending the AGM heard that the Association's income for the year was just under £5.3m which is an increase of over £100k from 2019; this was due to the number of new properties acquired during the year and the full impact of those acquired in the previous year.

The Finance Director reported that the operating costs increased by around 7%. This was largely due to increased expenditure on maintaining our homes. It was reported that we had invested just under \pounds 2.1m in maintaining and improving our existing homes.

The Finance Director explained how we had acquired 26 properties, which totalled £1.9m mainly acquired from partner associations to ensure that properties remain at affordable rent levels.

The surplus before pension adjustments was reported at £651k, which was £263k higher than budgeted. Assets at the end of the financial year was reported at £36m net of grant. In addition to the £1.9m spent on new acquisitions, the association spent £600k on component replacements such as windows, doors and kitchens.

Thanks, were given to the Staff, the Board, founder members, our partners, members of the Tenants Quality Panel and our lenders for their continued commitment and support.

The Chair also officially presented the Annual Report and noted that this year we used the report to celebrate our achievements over the last 25 years since the merger between Arawak and Walton housing associations.

The Chair said that COVID-19 has impacted on everyone's way of working in the last six months and gave staff recognition in continuing to provide a normal service to our tenants. The Chair reported that we had retained our IIP Gold status in the year, which confirms Arawak Walton's mission in not just about creating opportunities for our tenants but also for our staff. She said that staff teams have adapted well to working from home and then re-opening the office during these difficult times.

The Chair said that times may have changed but the ethos of the association remains true to its mission of providing quality homes to multi-cultural communities in Manchester, Trafford and Stockport, providing homes at truly affordable rents.



NEW HOMES

Over the summer we bought 7 new homes which are currently being refurbished. One of which is the first we have bought in the Sale area.

We are hoping to move tenants into these homes between the start of October and the end of November.

In July we also bought our 5th home that we agreed to deliver through our collaboration with Manchester City Council as part of the larger family's homelessness project.

The decision to provide individual fencing to previously open space in front of our housing was taken in consultation with our tenants as part of our longer term plan to maintain attractive and popular housing in the heart of the city.

This will be valuable more than ever, as our current lockdown restrictions remain in place in Greater Manchester.

We hope the families continue to enjoy their newly created gardens which has provided them with a private, safe relaxing environment.

 Our assessor reiterated that she had to remind herself about our size as a smaller association given we must perform at the same level as a larger organization in relation to regulatory requirements.
